The points towards an AKC Championship shall be awarded to the Winners Dog and the Winners Bitch of each breed or Variety based on the actual number of dogs or bitches competing in that breed or Variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused, or ordered from the ring by the judge, or from which all awards are withheld, shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

Through the years I have completed dozens of Champions owner-handled, winning Specialties, Groups, National Specialty awards and sled dog degrees. BISS GCH Bralin's Jack Be Nimble, SD (Jack) received The Top Producer Award for 2015.

My Husband Doug Jones and I married at the National Specialty at Purina Farms in 2000.

Bralin Siberian Huskies have sold around the country and have achieved Multiple Best in Specialty shows, Group wins and placements, National Specialty awards, Obedience titles, Sled dog degrees and weight pull awards. I also received the Working-Showing Trophy in 2007 thanks to my Husband and my Daughter (Marisa Brake) for their involvement and participation at the events.

As an approved AKC judge for Siberian Huskies I have judged multiple Specialty shows in the U.S. and abroad. It is always an honor to be invited to judge at Specialty shows. I love the Siberian Husky and judging them had become one of my greatest passions. .

I find it hard to write about myself, but here is a brief history of my life with dogs.

I bought a dog about 49 years ago from an elderly women who said you should show him he is really nice. Now haven't we all heard that but that is where it all started. Since that day I have learned a lot about the dog show world, the people and really what is a good dog. I currently own and show Rough Collies that I believe should be able to move, not just look pretty, and Australian Shepherds. I have finished several Collies and Aussies. I also help my daughter show German Shepherds. Now that is an experience. But through all of this, I have really learned about movement and structure.

I have judged several Bred By and Puppy groups at dog shows, and it is amazing how the good ones always stand out. I am currently President of the Anoka County Minnesota Kennel Club, Collie Club of America and the Australian Shepherd Club of America.

With that said I really feel honored to have been asked to judge the Breeder's Showcase once again for your show.

Official Standard for the Siberian Husky

GENERAL APPEARANCE: The Siberian Husky is a medium-sized working dog, quick and light on his feet and free and graceful in action. His moderately compact and well furred body, erect ears and brush tail suggest his Northern heritage. His characteristic gait is smooth and seemingly effortless. He performs his original function in harness most capably, carrying a light load at a moderate speed over great distances. His body proportions and form reflect this basic balance of power, speed and endurance. The males of the Siberian Husky breed are masculine but never coarse; the bitches are feminine but without weakness of structure. In proper condition, with muscle firm and well developed, the Siberian Husky does not carry excess weight.

SIZE, PROPORTION, SUBSTANCE: Height--Dogs, 21 to 23½ inches at the withers. Bitches, 20 to 22 inches at the withers. **Weight--**Dogs, 45 to 60 pounds. Bitches, 35 to 50 pounds. Weight is in proportion to height. The measurements mentioned above represent the extreme height and weight limits with no preference given to either extreme. Any appearance of excessive bone or weight should be penalized. **In profile**, the length of the body from the point of the shoulder to the rear point of the croup is slightly longer than the height of the body from the ground to the top of the withers. **Disqualification--**Dogs over 23½ inches and bitches over 22 inches.

HEAD: Expression is keen, but friendly; interested and even mischievous. **Eyes** almond shaped, moderately spaced and set a trifle obliquely. Eyes may be brown or blue in color; one of each or parti-colored are acceptable. **Faults--**Eyes set too obliquely; set too close together. **Ears** of medium size, triangular in shape, close fitting and set high on the head. They are thick, well furred, slightly arched at the back, and strongly erect, with slightly rounded tips pointing straight up. **Faults--**Ears too large in proportion to the head; too wide set; not strongly erect. **Skull** of medium size and in proportion to the body; slightly rounded on top and tapering from the widest point to the eyes. **Faults--**Head clumsy or heavy; head too finely chiseled. **Stop--**The stop is well defined and the bridge of the nose is straight from the stop to the tip. **Fault--**Insufficient stop.

Muzzle of medium length; that is, the distance from the tip of the nose to the stop is equal to the distance from the stop to the occiput. The muzzle is of medium width, tapering gradually to the nose, with the tip neither pointed nor square. **Faults** Muzzle either too snipy or too coarse; muzzle too short or too long. **Nose** black in black, gray, sable or agouti dogs; liver in red dogs; black, liver or flesh-colored in white dogs. The lighter-streaked "snow nose" is equally acceptable. **Lips** are well pigmented and close fitting. **Teeth** closing in a scissors bite. **Fault--**Any bite other than scissors.

NECK, TOPLINE, BODY: Neck medium in length, arched and carried proudly erect when dog is standing. When moving at a trot, the neck is extended so that the head is carried slightly forward. **Faults--**Neck too short and thick; neck too long. **Chest--**Deep and strong, but not too broad, with the deepest point being just behind and level with the elbows. The ribs are well-sprung from the spine but flattened on the sides to allow for freedom of action. **Faults--**Chest too broad; "barrel ribs"; ribs too flat or weak. **Back--**The back is straight and strong, with a level topline from withers to croup. It is of medium length, neither cobby nor slack from excessive length. The loin is taut and lean, narrower than the rib cage, and with a slight tuck-up. The croup slopes away from the spine at an angle, but never so steeply as to restrict the rearward thrust of the hind legs. **Faults--**Weak or slack back; roached back; sloping topline.

TAIL: The well furred tail of fox-brush shape is set on just below the level of the topline, and is usually carried over the back in a graceful sickle curve when the dog is at attention. When carried up, the tail does not curl to either side of the body, nor does it snap flat against the back. A trailing tail is normal for the dog when in repose. Hair on the tail is of medium length and approximately the same length on top, sides and bottom, giving the appearance of a round brush. **Faults--**A snapped or tightly curled tail; highly plumed tail; tail set too low or too high.

FOREQUARTERS: Shoulders--The shoulder blade is well laid back. The upper arm angles slightly backward from point of shoulder to elbow, and is never perpendicular to the ground. The muscles and ligaments holding the shoulder to the rib cage are firm and well developed. **Faults--**Straight shoulders; loose shoulders. **Forelegs--**When standing and viewed from the front, the legs are moderately spaced, parallel and straight, with the elbows close to the body and turned neither in nor out. Viewed from the side, pasterns are slightly slanted, with the pastern joint strong, but flexible. Bone is substantial but never heavy. Length of the leg from elbow to ground is slightly more than the distance from the elbow to the top of withers. Dewclaws on forelegs may be removed. **Faults--**Weak pasterns; too heavy bone; too narrow or too wide in the front; out at the elbows. **Feet** oval in shape but not long. The paws are medium in size, compact and well furred between the toes and pads. The pads are tough and thickly cushioned. The paws neither turn in

nor out when the dog is in natural stance. **Faults**--Soft or splayed toes; paws too large and clumsy; paws too small and delicate; toeing in or out.

HINDQUARTERS: When standing and viewed from the rear, the hind legs are moderately spaced and parallel. The upper thighs are well muscled and powerful, the stifles well bent, the hock joint well-defined and set low to the ground. Dewclaws, if any, are to be removed. **Faults**--Straight stifles, cow-hocks, too narrow or too wide in the rear.

COAT: The coat of the Siberian Husky is double and medium in length, giving a well furred appearance, but is never so long as to obscure the clean-cut outline of the dog. The undercoat is soft and dense and of sufficient length to support the outer coat. The guard hairs of the outer coat are straight and somewhat smooth lying, never harsh nor standing straight off from the body. It should be noted that the absence of the undercoat during the shedding season is normal. Trimming of whiskers and fur between the toes and around the feet to present a neater appearance is permissible. Trimming the fur on any other part of the dog is not to be condoned and should be severely penalized. **Faults**--Long, rough, or shaggy coat; texture too harsh or too silky; trimming of the coat, except as permitted above.

COLOR, PATTERNS, AND MARKINGS: All ranges of the allowable colors which are black, gray, agouti, sable, red, and white. May be solid colored. May have multiple shades. May have white markings. A variety of symmetrical or asymmetrical markings and patterns are common, including piebald. No preference should be given to any allowable color, marking or pattern. Merle or brindle patterns are not allowable and are to be disqualified. Merle is defined as a marbling effect of dark patches against a lighter background of the same color and is not to be confused with a color patch of banded guard hairs amid white, as is seen in dogs with allowable piebald. Brindle is defined as darker and lighter single-colored guard hairs producing a vertical tiger striping, not to be confused with banded guard hairs and a different color undercoat, which may produce some apparent horizontal striping.

GAIT: The Siberian Husky's characteristic gait is smooth and seemingly effortless. He is quick and light on his feet, and when in the show ring should be gaited on a loose lead at a moderately fast trot, exhibiting good reach in the forequarters and good drive in the hindquarters. When viewed from the front to rear while moving at a walk the Siberian Husky does not single-track, but as the speed increases the legs gradually angle inward until the pads are falling on a line directly under the longitudinal center of the body. As the pad marks converge, the forelegs and hind legs are carried straightforward, with neither elbows nor stifles turned in or out. Each hind leg moves in the path of the foreleg on the same side. While the dog is gaiting, the topline remains firm and level. **Faults**--Short, prancing or choppy gait, lumbering or rolling gait; crossing or crabbing.

TEMPERAMENT: The characteristic temperament of the Siberian Husky is friendly and gentle, but also alert and outgoing. He does not display the possessive qualities of the guard dog, nor is he overly suspicious of strangers or aggressive with other dogs. Some measure of reserve and dignity may be expected in the mature dog. His intelligence, tractability, and eager disposition make him an agreeable companion and willing worker.

SUMMARY: The most important breed characteristics of the Siberian Husky are medium size, moderate bone, well balanced proportions, ease and freedom of movement, proper coat, pleasing head and ears, correct tail, and good disposition. Any appearance of excessive bone or weight, constricted or clumsy gait, or long, rough coat should be penalized. The Siberian Husky never appears so heavy or coarse as to suggest a freighting animal; nor is he so light and fragile as to suggest a sprint-racing animal. In both sexes the Siberian Husky gives the appearance of being capable of great endurance. In addition to the faults already noted, the obvious structural faults common to all breeds are as undesirable in the Siberian Husky as in any other breed, even though they are not specifically mentioned herein.

DISQUALIFICATION: *Dogs over 23½ inches and bitches over 22 inches, merle, and brindle.*

How Dogs Are Judged

The entries at this show are divided in classes for each sex, with all male classes being judged first. Males are "Dogs" and females are "Bitches". Exhibitors may enter their dogs and bitches in the following classes:

1. Puppy 6 to 9 Months – puppies between 6 and 9 months of age.
2. Puppy 9 to 12 Months – puppies between 9 and 12 months of age.
3. Twelve to Eighteen Months – dogs between 12 & 18 months of age.
4. Novice – for dogs which have not won 3 – 1st Places in the Novice Class, or a first place in American Bred, Bred-by-Exhibitor, or Open classes.
5. Amateur Owner Handler dogs must be handled by owner and cannot be a professional handler, judge or assistant to a profession handler
6. Bred-by-Exhibitor – dogs must be owned and exhibited by their breeders.
7. American Bred – for dogs born in the U.S.A.
8. Open – for any dogs over 6 months of age, born in the U.S.A. or foreign.

The more mature, experienced show dogs are usually seen in the last 3 classes.

WINNERS CLASS

Competing in this class are the first place winners of the above Regular Classes and two awards are made: Winners and Reserve Winners. Winners Dog is judged immediately following the judging of all of the Regular "Dog" classes and Winners Bitch is judged immediately following the judging of all of the Regular "Bitch" classes.

CHAMPIONSHIP POINTS

The Winners Dog and the Winners Bitch are the only dogs at this show who will receive points toward their AKC Championship. The number of points earned is determined by the number of dogs defeated. See the AKC schedule of points elsewhere in this catalog. When the required 15 points have been won by a dog, he/she becomes an AKC Champion.

BEST of BREED COMPETITION

Dogs of either sex who are already Champions, along with the Winners Dog and Winners Bitch, and at a Specialty show, if undefeated in any Regular or Non-Regular Class, the winners of the Veteran Dog and Veteran Bitch and Sled Dog and Sled Bitch classes are also eligible to compete for the highest award of the day, Best of Breed. When the judge has selected the **Best of Breed**, a dog or bitch of the opposite sex is then chosen to receive the **Best of Opposite Sex to Best of Breed** award. Also, the judge will choose between the Winners Dog and Winners Bitch for the award of **Best of Winners**. At our show, we also have the judge choose between the winners of the Sled Dog and the Sled Bitch Classes (if any are entered) for the special award of **Best Sled Dog**.

NON-REGULAR CLASSES

At Specialty shows, clubs may offer special classes where no AKC points are earned. Non-Regular Classes offered today are: **Stud Dog & Brood Bitch**, each entry being shown with two of his or her offspring, the winner determined on the merits of the offspring; **Veteran Dog & Veteran Bitch**, each entry must be at least 7 years old; **Sled Dog & Sled Bitch**, each entry must have completed a predetermined number of miles in sanctioned sled dog races; and **Brace**, where two dogs are entered as one unit and judged on their conformation and how well they show as a pair.

PUPPY and VETERAN SWEEPSTAKES

All entries must be between 6 months and 18 months of age for puppies or over 7 years of age for Veterans, entered in the class as divided by age, and each must also be entered in a Regular (or Non-Regular for Veterans) Class at this show. The Sweepstakes judge need not be a licensed AKC judge. They are judged just as in the Regular (or Non-Regular for Veterans) classes and in the end, the winners of all the classes compete for the honors of Best in Sweepstakes and Best of Opposite Sex to Best in Sweepstakes. A portion of the entry fees is awarded to the winners. (See details elsewhere)

WHAT THE JUDGE IS LOOKING FOR

As a judge goes over each dog in the ring, he/she is comparing the dog to a mental picture of the perfect dog of that breed as defined by the AKC Standard. Each dog is judged on:

1. Physical structure (head, teeth, feet, bone structure, muscle tone, etc.)
2. Movement or Gait – how the dog uses that structure in the way he moves at a trot and is viewed from front, rear, and side.
3. Condition (proper weight, condition of coat, animation, etc.)
4. Temperament – penalizing heavily for shyness or viciousness.

Code of Ethics

In order to promote the highest ideals among Siberian Husky owners and breeders and to aim for the continuous improvement of the breed within the framework of the American Kennel Club approved breed standard, I pledge that:

1. I will accept a high ethical standard of breeding.
2. I will follow the rules of good sportsmanship in all Siberian Husky competition and activities.
3. I will fully explain to all prospective Siberian Husky purchasers the disadvantages as well as the advantages of owning a Siberian Husky.
4. I will attempt to help and befriend novice exhibitors, racers, and breeders.
5. I will keep well informed in the field of genetics and will work persistently to eliminate hereditary defects from the breed.
6. I will, before entering any breeding agreement, carefully analyze the conformation and the pedigrees of the prospective sire and dam and, keeping the breed standard clearly in mind, refuse the mating if in my opinion it will not be in the best interest of the breed. If I deny stud service, I will fully explain my reasons to the owner of the bitch.
7. I will refuse to deal with dog wholesalers or to sell puppies or dogs to pet shops, and I will include in all stud contracts an agreement to be signed by the owner of the bitch that no puppies resulting from the mating will be wholesaled or sold to pet shops.
8. Dogs must be maintained with their safety and good health in mind at all times, including adequate and appropriate attention, socialization, grooming, feeding, veterinary care, housing, and exercise.

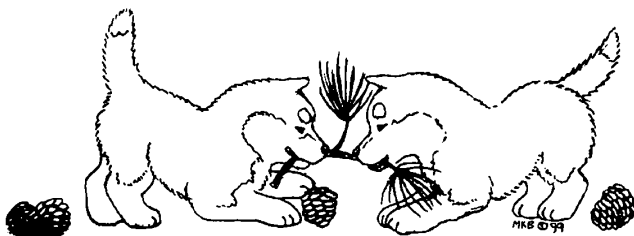

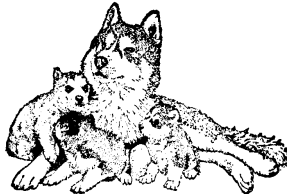

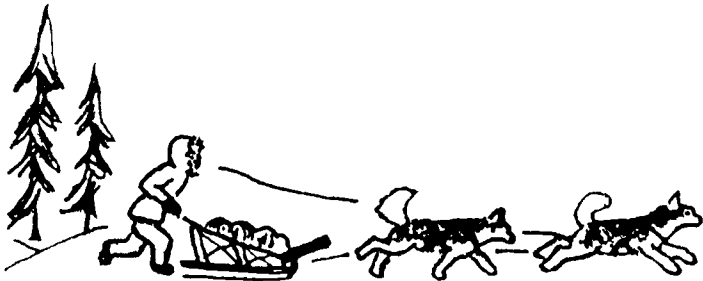

Each judge examines the three dogs. After each judge has examined the dogs, move each dog in a pattern agreed upon by the panel of judges.

Recall all dogs for final impression.

Move all dogs in a group again.

Repeat for females.

Tally all scores.

Bring dogs back into the ring.

Announce winner.

Bring bitches back into the ring.

Announce winner.

Winner of both sexes run around for a victory lap!

There will be 1 score sheet for First Impression. This sheet will be used when all dogs are in the ring. There will be individual sheets for the individual judging. There will be 1 score sheet for Final Impression. This sheet will also be used when all dogs are in the ring. This final sheet will also have a place for the total overall score of the dog. The scores from the three judges for each dog will be totaled and then averaged to create the overall winners. If there is a tie, all dogs involved in the tie will be called back to the ring. A majority of the judges will determine the winner.

Final scores only will be posted. Participants may receive their individual scores (Averaged score) if they request it.

Each judge will have an assistant to hold their clipboard.

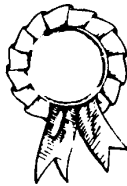

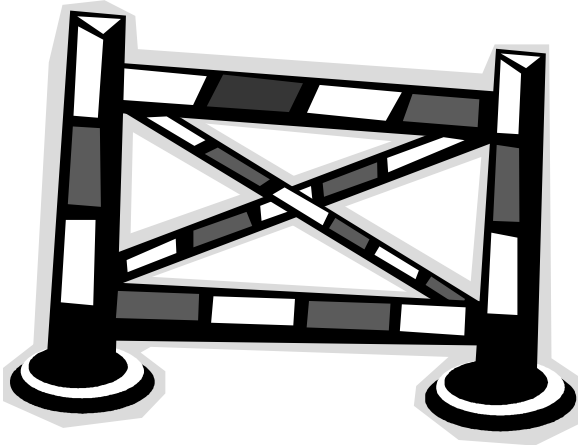

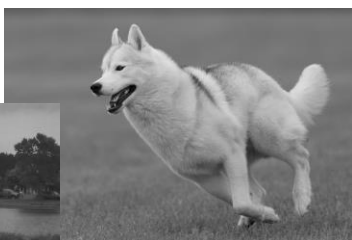
