Entry Fees

Entry fees \$25.00 per dog per test. Prices increase to \$30.00 per dog per test for Day of Show.

Open to all dogs at least 1 year of age by the day of the test that are individually registered with the American Kennel Club, recorded in the FSS program, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners program. A dog may enter only once per event (two events per day). Each event has an individual event number.

SHCTC Inc. Check Policy: All checks or money orders must be made payable in US Funds and drawn on US banks. Returned checks or money orders do not constitute payment for goods and/or services. All returned checks will be charged a \$30.00 returned check fee. Repeated returned checks and/or failure to repay debts to SHCTC Inc will result in being placed on "cash only" basis with the Club. Any payment received by SHCTC for any purpose, from any individual, group, or business with an outstanding debt to the Club, will first be applied to any outstanding debt. What this means, for example, is if your check to the Club for \$6.00 for a marked catalog is returned, you will be assessed an additional \$30.00 return check fee; and your resulting debt to the Club will be \$36.00. If you fail to pay this debt, but attempt to enter the trial, and send a check for \$56.00, \$36.00 from that entry check will first be applied to pay off your outstanding debt, leaving \$20.00 for the entry. In order for your entry to be accepted and processed, you will need to submit an additional \$36.00.

Fanciers Residing Outside the US: Please note that checks MUST be payable in US dollars and MUST be drawn on US banks, or they will not be accepted.

Fanciers wishing to pay via Pay Pal will be charged a \$2 handling fee per entry. See below.

ELECTRONIC PAYMENTS:

▪ E-MAIL entries are accepted. **Email entries add \$2 handling fee PER ENTRY PER DOG for Pay Pal payment. Make payment to brenda@nikosha.net**

Canadian exhibitors must make fees payable in U.S. funds. Exhibitors whose checks are returned for NSF will be assessed a \$30.00 service fee. Entries will not be accepted if received without a signature, fees or back of entry form with signed agreement. An official American Kennel Club Entry Form must be used. No entry will be accepted which is made subject to conditions.

If, because of riots, civil disturbance or other acts beyond the control of the test-giving Club, it is impossible to open or complete the Test, no refund of entry fees will be made. In the opinion of the inspection committee, any entry found to be lame, unfit to compete or a female in season shall not be allowed to test and applicable entry fees shall be refunded.

If the field secretary is notified of an absence AFTER entries close, and a run is available from the wait list to replace it, entry fees may be refunded; otherwise, no refunds for any reason for cancellations or absences AFTER entries close, except as provided in the rules for lame dogs and bitches in season identified by the inspection committee.

IMPORTANT!!!

Please write your dog's height at the withers next to the breed name on the entry form. If you do not do this YOUR DOG WILL BE ENTERED AS AN 18" HEIGHT.

Ribbon Prizes

Light Blue Ribbon will be awarded to each dog receiving a qualifying score.

New Title Rosette for dogs completing titles.

DAY OF SHOW:

Each test allows 125 dogs. If the event fills a wait list will be maintained and individuals notified if their entry can be accepted. If the test does not fill or waitlist entries are not available to fill running slots, then gate entries will be allowed to reach our limit of 125 dogs. Gate entries close at the secretary's desk at 8:30 am. Cost for day of show entries is \$30.00 per trial!

Covid Precautions

The club will adopt and follow Covid Precautions suggested by the AKC. If you are ill, have been exposed, or are having symptoms of Covid 19 please email or call the secretary or trial chair for guidance. All participants may be asked to sign the waiver and release of SHCTC at initial check-in regarding their participation in this event relative to Covid 19. Due care will be taken to be socially distance and avoid any close contact at the event.

Directions to Show site:

From the Twin Cities: Take Hwy. 7 west to Hwy. 15 in Hutchinson. Take a left on Main Street (Hwy. 15). Take a right onto Century Ave. SW. The fairgrounds entrance will be on your left at the third road. The building is on the east side of the fairgrounds.

From the North/West: Take I-94 to Hwy 15 near St. Cloud. Go South to Hutchinson. After crossing Hwy. 7, Take a right onto Century Ave. SW. The fairgrounds entrance will be on your left at the third road. The building is on the east side of the fairgrounds.

CAMPING

Running order:

First come, first serve. You must check in prior to the last dog in the test. The paddock master will take your run card and get you on the list after your dog is inspected. Events will be held concurrently.

INSPECTION: 8:30 AM

EVENT STARTS: 9:00 AM

You MUST show up for first check in by 1:00 p.m. Our event must be finished before 4:00 p.m. as the fairgrounds will be using the parking lot.

LUNCH BREAK: We will have a half hour lunch break at 12:00 p.m. No food or drinks available on site.

ELIGIBILITY and Conditions for FastCAT's

FastCATs are open to all dogs at least 12 months of age that are:

Individually registered with the AKC

Recorded in the Foundation Stock Service (FSS) program

Individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration

Dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration. To obtain a PAL number for your dog, please see the enrollment forms at the AKC website at:

Dogs enrolled in the AKC Canine Partners program. For information on this program please see the AKC website at:

Dogs with breed disqualifications are eligible to enter.

Females in season may not enter--BITCHES IN SEASON AND LAME DOGS WILL BE EXCUSED and entry fees shall be refunded

A dog may enter only once per event. (An event is defined by an event number)

A fee of \$30.00 will be assessed for any returned checks

You are responsible to have your dog's health records up to date.

The Club and/or Test Secretary assume no responsibility for incorrect or incomplete information given on the entry form.

The Club and/or the Test Secretary assume no responsibility for injury, or a dogs' failure to recall.

Any person, upon reasonable complaint, may be asked to leave the grounds as determined by the field committee. Children must always be under the control of their parents or guardian.

FastCAT ROLL CALL & INSPECTION

Roll call will be continuous. Competitors will check in at the check in table upon arrival at the test starting at 8:30 A.M. and continuing until running is complete. You can run both day's tests in the AM or PM with

at least 30 dogs or 1 hour in between. Each entry will be inspected for lameness, fitness to compete, and females in season as well as measuring for determining the handicap. If, in the opinion of the inspection committee, any entry found to be lame, unfit to safely compete, or a female in season, that dog shall not be allowed to enter and entry fees shall be refunded. There may be a short briefing with instructions and announcements before we begin. We will be moving things along as efficiently as possible to avoid a backup and long wait times.

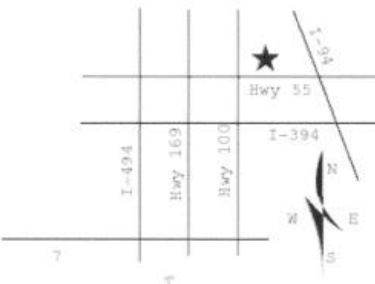
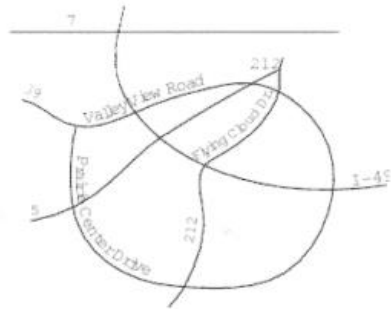

Attention Exhibitors

These trials may be canceled in the event of extreme weather conditions. No refunds will be given if the trial cannot be held or completed due to riots, civil disturbances, an act of God, extreme or dangerous weather conditions, public emergency, or any other reason beyond the control of SHCTC

Acknowledgment of entries will be made as soon as possible. Should such acknowledgment not be received by the exhibitor within a reasonable time, please contact the Field Secretary.

All dogs **MUST** be on a leash and under control while on the test grounds except during their runs. Exercise your dogs on any grass area and clean up after them! Exhibitors must exercise control over their children at all times while on the trial grounds. No gasoline or diesel generators are permitted within 100 feet of any tent or the test run.

SHCTC assumes no responsibility for any loss, damage or injury sustained by exhibitors, their dogs or property, children or guests.

Neither the test committees nor the test-giving club will be responsible for the loss or damage to any dog on the trial grounds, whether as a result of an accident or any other cause. It is clearly understood that every dog entered in the trial is in the care, custody and control of its owner or handler during the entire time the dog is on the test premises.

Exhibitors, Owners & Agents assume all responsibility for dogs & equipment on the show site.

Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form. Breed should be marked as "All American Dog."

ERRORS ON ENTRIES: Owners are responsible for the accuracy of the information required on the entry form. **Changes, additions, or corrections to an entry, entry substitutions, or cancellations by the owner must be received in writing (email accepted) by the Field Secretary prior to the closing date of the trial.** Other means of notification will not be accepted.

CONDUCT: It is expressly understood that all owners/agents/exhibitors are solely responsible for the behavior of their dogs and/or children. Any person(s) whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion

of the Trial Committee, be asked to leave the trial site. In such cases no refund of any fees/monies paid will be made.

All owners/agents/exhibitors and other persons attending these trials hereby waive any claim against the club or its agents, for any losses, damages, or injuries affecting self, dogs, children, or personal property.

TEST SITE: All dogs must be held on a leash or confined to a crate except when on the course for running. Dogs must be on a leash when being exercised, trained or when warming up.

SHCTC reserves the right to remove any dog in distress in a parked vehicle or crate.

Please keep the grounds clean by picking up after yourself and your dog. Dispose of 'poop' bags in the trash containers provided there. Please keep your crating area, the test site, grounds, and motel rooms and grounds clean so we may continue to be welcomed at these facilities.

WARM-UPS and training should be conducted in a sportsman-like manner to your dog, other dogs and competitors.

VACCINATIONS: Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

CRATING: Crating will be done in your vehicle.

Basic Information about AKC Fast Cat

- 1) Fast CAT Test is a timed, straight 100 yard dash for dogs. It is meant to be a fun and healthy activity of interest to any dog owner.
- 2) Dogs run singularly.

How are Fast CAT Points and Titles Awarded?

- 1) The dog's time to complete the 100 yard dash is converted into MPH.
- 2) A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers.
 - a) 18 inches or greater = handicap of 1.0
 - b) 12 inches to less than 18 inches = handicap of 1.5
 - c) Below 12 inches = handicap of 2.0
- 3) Points = MPH multiplied by the dog's handicap
- 4) Fast CAT titles are suffix titles earned at designated milestones.

BCAT = 150 points

DCAT = 500 points

FCAT = 1,000 points

FCAT# = every additional 500 points

- 5) The top 20 fastest dogs by breeds are published on the AKC website.

Course and Equipment

- 1) **Safety:** Safety is of utmost importance. It is the responsibility of the event committee to ensure the safety of the course, equipment and conduct of those involved with the event. It is recommended that the event committee run a test dog prior to the start of the event to ensure that the equipment functions properly and all personnel understand their jobs. Prior to moving the lure to position it for the start, the lure operator shall announce "hold your dogs" in order to caution owners.
- 2) **The Finish:** The club must provide enough room for a safe run-out area. SHCTC will attempt to use a minimum of 50 yards. It is recommended an owner or someone familiar with the dog be at the finish in order to catch the dog once the course is completed. SHCTC will attempt to provide assistance at the end of the course to collect the dogs if the owner requests it.
- 3) **Timing Devices:** SHCTC will use electronic timers. The time to complete the 100 yard dash is recorded to the nearest 1/100th of a second. The time starts when any part of the dog breaks the electronic beam at the start line. The time stops when any part of the dog crosses the finish line. Stop watches will be used as a backup if the electronic timers don't function. In the event of manual timing, a starter's flag will

signal the start when the dog's nose crosses the starting line and the time will be recorded by two timekeepers, each operating individually, at the finish line. The time will be the mathematical average of the two manually recorded times.

4) **Lure Equipment:** SHCTC uses a continuous loop system. The lure is propelled by a CONTINUOUS LOOP SYSTEM whereby the lure, consisting of a plastic lure dragged along the ground in front of the dog by a take-up reel. Safety is the number one consideration in running this event.

5) **Field Conditions.** The field is reasonably flat, level and mowed. The actual running area is approximately 150 yards long x 5 yards wide, with a snow fence barrier. The release line is ten feet behind the starting line. The course is 100 yards long with finish line timers (electronic and manual) and a 50-yard run-out area. Handlers may not walk the course with their dogs during the actual test, but they may walk the course to the catch area **BEFORE** their dog is released.

6) The **huntmaster** has control of the course. The huntmaster is in charge of all dogs and handlers on the field, shall ensure handlers understand safe release and retrieval procedures, shall ensure the lure is properly positioned, shall ensure the lure operator, timers and starting line signal person are ready, shall signal the lure operator to start the lure and shall give the verbal signal "tallyho" to release the dog.

7) **For handlers with multiple entrants:** Please indicate that your dogs should be separated in the running order.

8) **Check in and Inspection:** Dogs must be checked in and inspected prior to each run. Inspection will check for general fitness and for females in season, which are not permitted to run. In addition, the dog's handicap must be verified at the time of inspection. You will receive a card at inspection that will be turned in to the Paddock Master.

9) **At the line:** The Paddock Master will coordinate the running of the dogs according to his/her best discretion. Dogs will be called "to the line" and "in the hole" positions. Dogs that are not present "in the hole" will be moved down and the next available dog will be inserted into the running order to keep things moving. The missing dog will be inserted into the running order as convenient when they arrive. So, if you miss your run time, you will not be required to wait until all the dogs have run. You can run, within reason, when you arrive.

10) **Operation of the Lure:** The Lure Operator's job is to 1) ensure a safe run by operating the lure correctly, and 2) to get the best score for your dog. If your dog is new to the sport, tell the Huntmaster! That may mean operating the lure differently, to get his/her attention, as opposed to an experienced dog that needs little to no encouragement. If your dog is particularly fast for its breed, simply advise the Huntmaster about your "Fast Dog." They will tell the lure operator, who will adjust the running of the lure to accommodate this. The lure operator has experience and knowledge related to running various breeds, but every dog is different. We want you to have a good score.

11) **Schedule and Trial Hours:** 9 a.m. until all runs are completed or 4 p.m., whichever comes last. In any event, all entrants present during the posted times will be allowed to run, if conditions are safe. **Handlers MUST check in and turn in card for first run NO LATER than 1 p.m.**

FUN RUNS!

Unsure what your dog will think? Come try it out first.

Fun runs will be available on Friday after setup until dusk. Approximately 4 to 7:00 p.m.

\$5 per run

General:

1. All entries must be one year of age or older on the day of the test or trial.
2. Dogs not present by the end of the test will be scratched.
3. Each entry will be examined at **inspection**. In the opinion of the inspection committee, any entry found to be lame, unfit to compete or a female in season shall not be allowed to enter and entry fees shall be refunded.
4. Dogs will be inspected before each Event.
5. We will separate the running of multiple dogs handled by a single handler.
6. Dogs may wear any collar except a choker collar, a harness, a collar with prongs or an electronic training collar. The collar should be snug to minimize the chances of getting hung up on something during the run. Owners should be aware that there is a chance that tags hanging from the collar could become entangled on something during the run. Owners may use clips or rubber bands to hold the dog's hair. The owner assumes responsibility for the safety of the dog with regard to the dog's collar and paraphernalia on the dog.
7. Continuous loop system will be used. Lure is a white plastic bag.
8. The field committee reserves the right to bar known aggressive dogs from the event site.
9. There will be a \$5 fine assessed for any loose dog not taking part in the course in progress, or for anybody caught not picking up after their dog, or leaving garbage on the field.
10. No one will be allowed on the field without the express permission of the field chairman, except the appointed field committee.
11. Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.
12. Control of dogs strictly enforced, on leash at all times except when running.
13. Clean up and carry out all trash.
14. Please pick up after your dog and put in receptacles provided at site.

SCHEDULE (Quick Check)

1. A handlers' meeting will be held 30 minutes prior to run start time.
2. All dogs will be inspected for soundness prior to running in a trial beginning at 8:30am, and will continue to be inspected throughout the day.
3. AM and PM run start times are 9:00 am.

Check-In: Please check-in for your first run no later than 1 p.m.

Field Hours: 8:30 am to the conclusion of both events scheduled for the day of the tests.

Handlers Meeting: 8:30am for all runs.

Lunch: A 30-minute lunch break will be scheduled at the discretion of the Event Committee (12:00 p.m.).

Scheduling of Runs / New Concurrent Procedures / Note to Handlers:

AKC is strongly recommending that all FastCAT events be scheduled to avoid crowds at the event site because of the Covid-19 virus. We will be running a first come, first served event. We will be inspecting and running dogs all day. You do not need to be there at the start of the event. Sleep in and come at 10 or 11 to avoid the mad rush at the beginning of the day. Run your dog, wait about an hour, get your dog inspected again and run your dog again and go home.

Any dog not present by the time the test ends will be considered absent.
